## TEMPERS FLARE IN TRIAL OF MALAYSIA'S ANWAR

Tempers flared on the third day of the trial of sacked Malaysian finance minister Anwar Ibrahim when the judge warned two defense lawyers that they could be held in contempt of court for arguing with him.

"I would like to take a serious view of the behavior of the counsel," High Court Judge Augustine Paul said after defense lawyer Gurbachan Singh had called him rude.

"I may exercise all the judicial muscle I have to bring contempt of court proceedings...against both counsels."

Singh and colleague Christopher Fernando also admonished the judge when he allowed witness Police Special Branch Director Mohamed Said Awang to state an opinion about Anwar.

Anwar was sacked from the cabinet on September 2 and arrested 18 days later after leading anti-government protesters through the capital.

He has pleaded not guilty to five counts of corruption and five of sodomy in a trial which started Monday and has focused world attention on Malaysia's politics and human rights record. [End quoting]

## US MARTIAL LAW COMING? COHEN PREDICTS ARMY WILL PATROL STREETS

"Terrorism is escalating to the point that Americans soon may have to choose between civil liberties and more intrusive means of protection," says Defense Secretary William S. Cohen.

The nation's defense chief told the *Army Times* he once considered the chilling specter of armored vehicles surrounding civilian hotels or government buildings to block out terrorists as strictly an overseas phenomenon. But no longer. "It could happen here," Cohen said he concluded after 8 months of studying threats under the Pentagon microscope. Free-lance terrorists with access to deadly chemical and biological bombs are "going to change the way in which the American people view security in our own country," he predicted in a Sep. 10 interview.

Cohen is calling for the government to step up its efforts to penetrate wildcard terrorist organizations. "It's going to require greater intelligence on our part—much greater emphasis on intelligence gathering capability—more human intelligence, and it's going to take more technical intelligence," he said.

But using the U.S. military in a domestic law enforcement role would require revisions to laws in force for more than a century, cautions Shreveport attorney John Odom, Jr. "You can't do it from the Defense Department side unless Congress dramatically revises the Posse Comitatus laws," said Odom, a colonel in the U.S. Air Force Reserve and a reserve Judge Advocate.

"The 1878 law specifically prohibits the use of the military in domestic law enforcement unless authorized by Congress or the *Constitution* and does not allow for military intervention through action by the Secretary of Defense or even an Executive Order from the President," Odom said. "We're trained from the first day of Judge Advocate school to think of Posse Comitatus!!!" said Odom. "If Secretary Cohen is suggesting that the Department of Defense be involved, it may be part of a legislative package, but it will not happen unilaterally without a lot of folks thinking long and hard about it."

Cohen said terrorism would be a top priority in 5 new areas he plans to focus on now that he has wrapped up his first defense budget, the quadrennial review of the military, and a new 4-year defense strategy. Other goals include modernizing the military, improving troops' housing and other benefits, streamlining the defense bureaucracy and shaping new military relationships and contracts across the globe. Brown detailed for the first time conversations he had with Mrs. Clinton involving the nature of her relationship with the late Vince Foster.

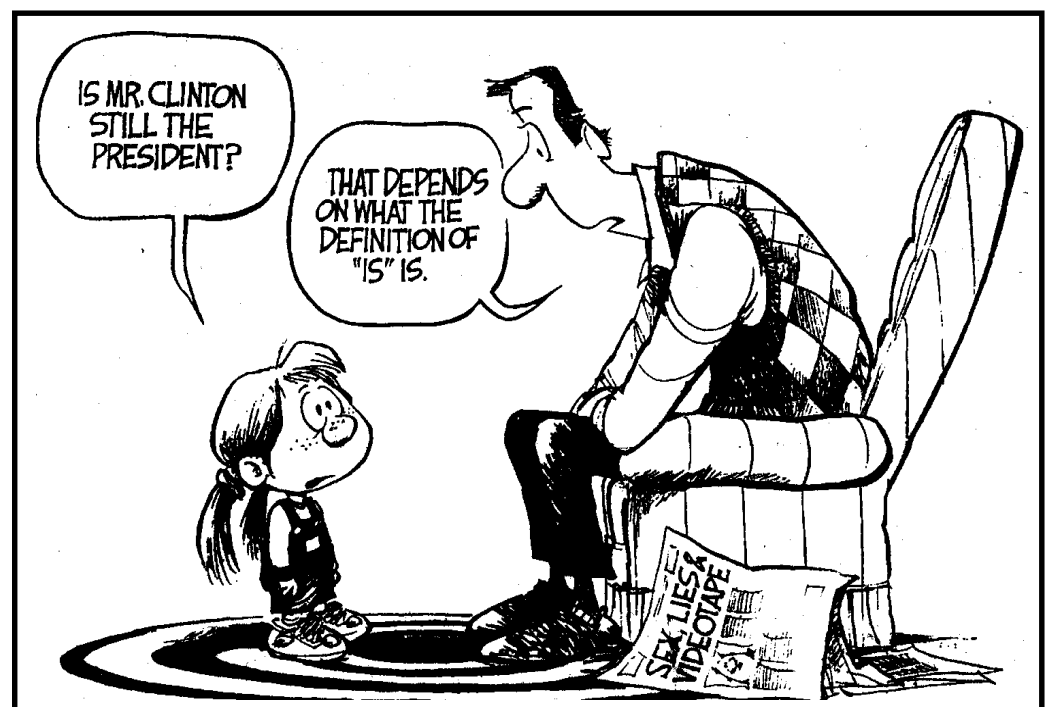
Brown said Hillary Clinton's relationship with Foster was of a sexual nature.

### YEAR 2000 WOES: THEY'RE BANKING ON IT

Central bank plans to print more money in anticipation of y2k panic.

The Bank of Canada plans to print extra bank notes in the coming year, anticipating a run on cash by people living in fear of the Year 2000 computer bug. A number of banks are expecting that nervous customers will sock away more bills than usual as 2000 approaches. As a result, the central bank is working with financial institutions to determine exactly how much extra money it will need to print.

"I think people might think it is prudent to hold a bit more cash," a Bank of Canada spokesman said. "We are, as other central banks, looking ahead and saying there could be some additional demands as y2k [the year 2000] approaches."

The Bank of Canada is not alone in its decision to print more money. In a report published this month, the Bank of England said it will run off extra cash in the run-up to

January, 2000.

And in New Zealand, the Reserve Bank said it will keep old bank notes—which are due to be replaced next year by flexible plastic ones—in vaults instead of destroying them to ensure there will be enough cash available to its customers into 2000.

As well, the U.S. Federal Reserve Board announced last month it will have an extra \$50 billion in cash on hand, just in case there is a run on money. The Fed usually keeps \$150 billion in currency in reserve within government vaults. However, it plans to raise the amount it keeps in reserve to \$200 billion over the next year....

Year 2000 is also giving corporate directors cause for concern. For instance, Canada Trust Co.'s board meeting ran late recently partly because there were a number of questions related to the trust company's 2000 readiness. Eugene Miller, the head of Detroit-based Comerica Inc., said 2000 is arguably the most important issue facing his board of directors. "Those boards that are not taking it seriously are making a mistake, because they can be held liable if something happens," he said.

WHAT that story ISN'T telling you, of course, IS THAT THERE IS NOT ENOUGH CASH IN THE BANKING SYSTEMS OF EITHER THE U.S. OR CANADA TO COVER MORE THAN 1.5% OF THE AMOUNT OWED TO DEPOSITORS! ### THE NOSE KNOWS

From *POPULAR SCIENCE* magazine, Nov. 1998: [quoting]

A miniature nose may soon begin turning up in gas appliances. Referred to as the nose-on-a-chip and developed at the Oak Ridge National Laboratory in Tennessee, the device is capable of "smelling" natural gas leaks in stoves and heaters, providing protection against explosions. It can also detect deadly carbon monoxide, a colorless and odorless gas that's the byproduct of incomplete combustion.

The device, which can be configured to notify the fire department when a leak is detected, consists of arrays of tiny (0.2mm to 0.5mm) finger-shaped silicon sensors on a computer chip. The sensors bend in the presence of certain chemicals. For instance, when hydrogen diffuses into a palladium-coated sensor, the metal expands. That expansion triggers an alarm. By selectively coating the arrays with various chemicals, the chip can be customized to detect virtually any chemical—and even several simultaneously.

The nose, which should be commercially available within two years, is inexpensive and requires little power. It's also extremely sensitive. "With certain agents, it offers sensitivity in the range of 10 parts per billion," says Oak Ridge developer Charles L. Britton. Most existing sensors are only capable of detecting single chemicals, and have large volume and power requirements.

"We can put hundreds of them in a single square centimeter," says Britton, "and they can

be mass-produced using silicon micromachining techniques, making them inexpensive."

Along with use in gas appliances, Britton sees the possibility of stand-alone devices that would monitor the home for harmful gases, smoke, and other hazards. —Douglas Page [End quoting]

A very useful device, especially since it is so inexpensive.

### SCRABBLE BLOOPER

Just spell it s-o-r-r-y

How many points is the word "oops" worth in Scrabble?

The Caldor department store chain apologized Tuesday after 11 million copies of an advertising circular showed two smiling boys playing Scrabble around a board with the word "rape" spelled out.

Caldor spokeswoman Jennifer Belodeau said store officials do not know who did it or how it got past the proofreaders.

She said store officials learned of the problem late Friday when a customer called to complain about the advertisement, which appeared in a 44-page toy-sale insert that was distributed over the weekend in 85 newspapers in the Northeast, where Caldor operates 145 stores.

The word "rape" is spelled vertically on the board. At least two other words on the board are nonsense words.

"Obviously, it's a mistake," Belodeau said. "It's not something that we would ever have done intentionally. While we do proofread things very carefully, with the volume on that particular page, that was something that was missed."

Belodeau said the Scrabble board in the ad originally was set up by a creative agency hired by Caldor.

She would not identify the agency.

"It could be that everybody got up and took a break, and some unknown source came in and fooled with the board. There's no way for us to know," she said.

Belodeau said Caldor and the outside agency were responsible for proofreading.

She said the department store chain got about 10 complaints from customers.

"I was just shocked that it was allowed to slip through the cracks," said Deirdre Armon, a mother of two girls and an avid Scrabble player who called a TV station in

Hartford when she noticed the word.

Finally our pastor slid an arm around each of us and led us away from the small mound of newly turned dirt. "Pat, Jeff," he said, "saying goodbye to your son was probably the hardest thing you've ever done. But I have to

warn you, the months ahead will be even tougher."

I didn't see how anything could be worse than losing Blake.

"A loss like this puts a terrible strain on a marriage," he continued. "Couples end up divorced. I'm not saying that's going to happen to you, but don't be afraid to ask for help."

We won't need help, I thought. Nothing could destroy our marriage.

"You don't have to worry about us," Jeff said firmly. "Pat and I will get through this the way we get through everything—together."

For days afterward I was never far from Jeff, nor he from me. We tried to be strong in front of the boys. It was best for them if things settled down and returned to normal.

Privately I wondered if they ever would. Even the simple act of waking up wasn't the same. Jeff and I used to savor the early morning—before work, chores and the kids came rushing at us. We'd talk a while, holding each other. Then I'd listen as Jeff said a prayer. It made us feel centered to start the day with a quiet moment together. He eased out of my grip, out of bed, and started getting ready. Before he left he kissed me on the forehead and told me reassuringly, "You'll be okay, Babe. Call me."

I wasn't okay. Not even close. After I got Scott and Brent off to school, I crept back to bed, exhausted from the effort of trying to be cheerful for them. Around lunchtime, still in my nightgown, I dragged myself into the kitchen. Mechanically I lined up bread, peanut butter and grape jelly on the counter and began assembling a sandwich. I trimmed the crust off the bread. Just the way Blake likes it, I thought.

With a jolt, I realized what I was doing. I bolted from the kitchen and flung myself on Blake's bed, stifling my sobs in his pillow. "My sweet baby," I whispered. Late in the afternoon I heard the rumble of a school bus. I can't let the boys see me like this. I forced myself to get up and get dressed.

When Jeff came in that evening, he asked with a hopeful smile, "How'd it go today?"

"It was awful," I replied. "I barely made it out of bed."

"Oh, Babe," he said, pulling me close. "It'll get better."

As the weeks passed, it did seem to get easier—for Jeff. He had his work. But for me, the ache of loss only deepened. Laundry, cooking and cleaning became mere drudgery, no longer games to dawdle over with my little

It became harder for us to live in our home without Blake. Brent refused to sleep in the bedroom they had shared. We all avoided that room, still filled with Blake's clothes, toys and lingering little-boy smell. But no matter where we went in the house, something called forth the memory of the sunny-faced toddler whose giggles still echoed in our minds.

One evening as Jeff helped me clear the table, he offered a solution. "I think we should move," he said. "Maybe it'll give us a new start. I want us to be a family again."

I nodded warily. I wanted that too, but I was beginning to wonder if the warning our pastor had given us was coming true.

"Most of all," Jeff added, his gaze resting on me tenderly, "I want my girl back."

"That girl is gone forever," I snapped, not thinking. "Just like Blake." Immediately I felt bad, but it was too late to take it back.

We looked for a house for months, with no luck. Finally we decided to build our own. After long days at the store, Jeff grabbed quick suppers with us, then rushed out to work on the house, leaving me alone with the boys. The tension between us escalated. We had rarely exchanged a harsh word in all our years of marriage. Now we bickered constantly. He

was determined to stay within budget, and I didn't see the point of building a home if we had to cut corners. We stopped smiling at each other, stopped touching. That patient "I'm praying for you" expression on Jeff's face infuriated me. The qualities that had once drawn me to him—his quiet strength, his steadiness—left me cold.

One day after a nasty skirmish, I caught Jeff muttering, "That woman will send us to the poorhouse!"

I felt a stab of hurt and a sudden, dreadful revelation: Somehow I had gone from being his "Babe" to "that woman".

"I'm sick of this!" I cried, powerless to stem the rush of angry words from my lips. "I'm sick of pretending everything's okay between us. Maybe we should just call it quits!"

# New World Order's Efforts To Capture A Country Through Finances

## **THE FEUD**

*How Mahathir and Anwar became embroiled in a clash that threatens to send Malaysia into upheaval.*

To Prime Minister Mahathir Mohamad, who has a passion for flying and sailing, Malaysia's annual air and boat show on the island of Langkawi was an event he hated to miss—even as his nation stumbled through an economic crisis. So Mahathir decided to hold the Dec. 3, 1997 meeting of the Malaysian Cabinet on the island, instead of in the capital of Kuala Lumpur.

But by the time he arrived at the elegant Gunung Raya hilltop retreat, Mahathir was in for a jolt. His next-in-command—Deputy Prime Minister Anwar Ibrahim—had virtually concluded business without him, according to sources knowledgeable about the meeting. In what amounted to an economic coup, the cabinet had decided to adopt an austerity plan similar to those imposed on neighboring Thailand and Indonesia by the International Monetary Fund. The plan would slash public spending and halt infrastructure projects championed by Mahathir.

The new policy was a stunning rebuke to Mahathir. Since the onset of the Asian crisis five months earlier, he had been railing against a perceived Western conspiracy and insisting Malaysia could maintain its breakneck growth. Mahathir's reaction: he humbly agreed to go along with his Cabinet's decision—but on the very next day undermined it by announcing Malaysia would proceed with a controversial \$2.7 billion rail and pipeline project. Alarmed investors immediately sent the ringgit to a new low.

Those intrigue-filled days in December were a prelude to what has become Malaysia's worst political crisis in nearly three decades. Although Mahathir and Anwar had long had differences over economic stewardship and management of political spoils, that rift widened

as Asia's financial crisis wore on and the two leaders worked increasingly at cross-purposes. Ultimately, the dispute led Mahathir to clamp controls on the currency and jail his deputy, casting himself as an international rogue.

Today, the clash threatens to send Malaysia into upheaval. Anwar, a central player in the old patronage system, has now emerged as a hero of the swelling reformasi movement, which advocates a more open society and economy. He goes on trail Nov. 2 on 10 charges of sodomy and corruption. A conviction could turn the protests into an ugly confrontation.

How did the two men end up so militantly opposed to each other? Over the past month, *BUSINESS WEEK* interviewed dozens of Malaysians from both camps, including Anwar prior to his arrest, prominent pro-Mahathir businessmen, informed academics, and Anwar associates. Together, they draw portraits of the one-time allies and their battle to control the future of Malaysia Inc., an economic model that uses patronage to speed economic development.

**HEIR APPARENT.** It is a tragic spectacle. Just a few years ago, Mahathir was poised to retire from politics as the prickly but nonetheless brilliant and erudite architect of a model developing nation. And Anwar, the anointed successor, would smoothly take the helm of the ruling United Malays National Organization (UMNO) and lead a modern, politically stable 21st century economy. Former Islamic radical Anwar, 51, was the more Western-friendly of the two, often quoting Shakespeare and hobnobbing with the moguls of international finance. Mahathir, 72, has long taken a confrontational stance toward the West. But like Anwar, he viewed foreign investment as key to Malaysia's economy and advocated freer trade within Asia.

Both also were savvy politicians who steered choice deals to their allies in the business community. Just last year, foreign investors criticized the government's handling of insider deals by Malaysia Resources Corp., a media and infrastructure company controlled by Anwar allies.

Still, Anwar had a reform agenda. In recent years, he increasingly advocated the rule of law and more transparency. But until the crisis erupted, he was willing to bide his time until it was his turn to run the country. "He was that close to power," says Anwar's wife, Azizah Ismail, holding her thumb and forefinger close together. "He was tolerating a lot."

Perhaps the key difference between the two leaders was their outlook on the world. Anwar quickly realized that the meltdowns of Thailand

and Indonesia were caused by excessive borrowing, overbuilding, and big trade imbalances—and that Malaysia's situation was similar. Malaysia didn't yet need an IMF bailout, but he feared its economy would implode without swift action. While this surely would hurt his business allies, Anwar was willing to have Malaysia absorb economic pain first and rebuild for the future.

Mahathir looked at it differently. Unlike the ascendant Anwar, he was in the twilight of his career—and feared for his legacy. While Anwar hinted he wanted to end patronage, Mahathir genuinely thought the system he proudly calls "Malaysia Incorporated" was a legitimate model for developing nations. A handful of wealthy businessmen are singled out for privileges and given the role of creating jobs, implementing big projects, and keeping the economy and the ruling party humming. Then wealth trickles down from Mahathir's chosen few to the many. "We view Malaysia as a corporation, and the shareholders in the government are companies," says Mustapha Mohamed, the new No. 2 at the Finance Ministry. "To the extent you help the bigger guys, the smaller guys benefit." When Western agencies attacked his system as institutionalized corruption, Mahathir "was quite angry," says Francis Yeoh, managing director of YTL Corp. and a longtime Mahathir ally. "He found it incredibly hypocritical and unfair." Mahathir declined to be interviewed.

When Malaysia was growing 8% to 10% annually, the uneasy alliance worked. But the crisis in Malaysia's financial markets provoked a fury in Mahathir toward the outside world. The feud broke out two days after Mahathir returned from a two-month globe-trotting sabbatical in July, 1997, just as the crisis hit. He began blasting foreigners—and he kept it up for months. He blamed "international manipulators" such as financier George Soros and Jewish traders for trying to undo the success of the Muslim Malaysians. **[H: Gosh, was he making an understatement—try undoing the success of THE WORLD.]**

Malaysian officials grew weary of the Mahathir effect on the currency and stock markets. The central Bank Negara tracked the plunges in the ringgit every time Mahathir lashed out, and officials showed him the data. If Mahathir would tone it down, they suggested, the ringgit might stabilize. For a while, he complied.

Meanwhile, Anwar tightened up on money and began urging Mahathir to suspend big infrastructure projects. When Mahathir agreed on Sept. 5 to postpone the \$5.3 billion Bakum Dam, a new airport, and plans to build the world's longest building, the market enjoyed the largest one-day surge in over three years. But it fizzled as the crisis deepened.

Mahathir's patience ran out. On Nov. 21, he set up the National Economic Action Council to devise remedies. It included Mahathir, Anwar, economic adviser Daim Zainuddin, and prominent economists and business leaders. Council members quickly squared off over the best cure for the crisis: the IMF's austerity medicine or the easy money and massive government spending Mahathir preferred. "We argued back and forth, back and forth," recalls Zainal Aznam Yusof, deputy director of the Institute for Strategic & International Studies, a government think tank. **[H: Boy is that an**



**oxymoron or what?]** But as the months wore on, “we became convinced that you cannot go on with tightening monetary policy. You might push the economy over the edge.”

Then came a move that rocked market confidence and drove a deeper wedge between Anwar and Mahathir: the bailout of big infrastructure developer Renong. Headed by longtime Mahathir associate Halim Saad, it was precisely the sort of company Mahathir was determined to save, and was choking under a pile of debt. In a complex transaction that left minority shareholders in the cold, Renong subsidiary United Engineers Malaysia (UEM) paid a stiff premium to buy out the parent company. Analysts suspected that Mahathir allies benefited, a charge Renong denied. **[H: I wish I had time to tell you in detail what “Renong” is all about for it is about the most important network of highways and infrastructure a nation MUST HAVE TO EXIST.]**

Anwar, miffed at the way the bailout was handled, ordered regulators to investigate. UEM was found to have broken disclosure rules, but the punishment was light. “Within two weeks of the Renong-UEM deal being announced, it was all over” for Malaysia’s stock market, says a local securities trader.

Five days after the Renong bailout came the meeting on Langkawi. Anwar, having just met with IMF Managing Director Michael Camdessus and acting on the advice of his central bank governor, Ahmad Don, had concluded that the IMF formula of tight monetary policy and government austerity was right. The Cabinet agreed. When Mahathir arrived, the virtual IMF program was a fait accompli.

**“MORAL OBJECTION”.** But local business leaders were growing unhappy with the effects of Anwar’s policies. So was Mahathir. “The intensity of business collapses and bank collapses was like tenpins falling every day,” says YTL’s Yeoh. “He couldn’t stand it.” Adds another prominent businessman: “He doesn’t believe in bankruptcies. He has a moral objection to them.” **[H: Isn’t it time SOMEONE had some moral objections to lies, cheating, stealing and total manipulation?]**

The attempts to get around Anwar’s IMF-style budget grew. According to Anwar associates, Daim called the CEO of Bank Bumiputra, Abdul Aziz Othman, and asked him to lend \$20 million to a company in trouble. After checking with Anwar, these sources say, Aziz told Daim no. Tensions between Daim and Anwar rose. Daim declines to comment on the allegation or other matters related to Anwar. Bank Bumi did not respond to requests for comment.

By February, Mahathir was pushing for more bailouts. Anwar aides contend that the Prime Minister had broached the idea of using Petroliam Nasional (Petronas) to bail out his son Mirzan Mahathir’s shipping company, Konsortium Perkapalan, which had trouble servicing its \$490 million debt. Both Mirzan and Petronas deny the Prime Minister had anything to do with the \$220 million purchase of KP’s assets by a Petronas unit. “I didn’t ask him to intervene. I just told him that any businessman faced with this situation will have to sell and pay down the debt,” says Mirzan, who holds a Wharton MBA. “We believe we are a viable company.”

But the deal reminded many Malaysians of Indonesia’s Suharto, who fell partly because of his family’s greed. In 1994, opposition politicians criticized the stakes Mahathir’s sons had in over 200 companies. Now, those concerns were resurfacing. Comparisons with Suharto “must have upset Dr. Mahathir, even though there are important differences between the two,” says University of Malaya economist K.S. Jomo.

In April, the Anwar-Mahathir rift grew wider. Speaking in New York at the elite Council on Foreign Relations, Anwar lauded the virtues of “creative destruction”. Mahathir would deride that term time and again in speeches months later. Anwar later told Mahathir he was trying to push Malaysia’s agenda by calling for reform of the international monetary system. But he did not mince his words in New York about what was going on back home. “What are meant to be mere crutches often become permanent appendages, spawning a dependency mentality AND RENDERING THE PUBLIC PURSE A RICH FEEDING GROUND FOR ALL KINDS OF PARASITES,” HE SAID TO APPLAUSE. **[H: The CFR yet!]**

Yet while he was away, Anwar got wind of another attempted bailout, this time for Daim pal Tajudin Ramli at Malaysia Airlines. **[H: How do you feel about TWO airlines?]** “The moment my back is turned, they push through this nonsense,” he told his aides. “How am I supposed to explain this over here?” Mahathir denied he was involved. Anwar suggested the Finance Ministry would veto the deal, and it was never done.

Shortly after Anwar returned home, Suharto fell. Mahathir had met with the aging strongman in Cairo on May 14 at the G-15 summit. Mahathir left the meeting speaking of “foreign parties trying to unseat us both”. The new Indonesian President, B.J. Habibie, was a friend of Anwar.

**ESPIONAGE CHARGES.** So was Indonesian newspaper editor Nasir Tamara, who caused a flap on June 2 when he addressed Malaysian scholars, businessmen, and social activists assembled by Anwar’s think tank. While he didn’t mention Malaysia, Nasir spoke of cronyism and explained how the reformasi movement toppled Suharto. An Anwar aide says Mahathir questioned his deputy about the speech.

By the time the UMNO General Assembly meeting began on June 20, Mahathir had decided to get rid of Anwar—and the open battle began. Information packets given to the 1,900 conference attendees all contained a book alleging homosexual and heterosexual affairs by Anwar. The book, *Fifty Reasons Why Anwar Cannot Be Prime Minister*, also charged him with spying for a foreign power. Diplomats and other sources say the book could not have been distributed without Mahathir’s knowledge.

Anwar’s camp returned fire. The leader of the UMNO Youth league, Ahmad Zahid Hamidi, criticized the government for “corruption, collusion, and nepotism.” Mahathir blasted back the next day, saying that everyone, including Anwar and his allies, had benefited from the state’s largesse. Days later, Mahathir announced that Daim would take over management of the economy. Anwar’s role was sharply curtailed. At a mention of Daim during an interview with


*BUSINESS WEEK* on June 30, Anwar crossed his arms and visibly stiffened.

By the end of August, Malaysian stocks were down 80% from the previous year. On Sept. 1, Mahathir shocked the world by imposing currency controls. He told Anwar to resign by 5:30 p.m. the following day “or I’ll humiliate you tomorrow”, according to former Anwar aides. He refused. “I told him, ‘If you resign it’s like an admission of guilt,’” Anwar’s wife Azizah recalls saying the next day over a lunch where the food went uneaten. Anwar then went to his Finance Ministry office. At 5:30, the power went off at his official residence. At 7, Anwar received a letter from Mahathir saying he had been dismissed.

“I tried to work within the system,” Anwar told *BUSINESS WEEK* three days after his ouster. But now, Anwar acted like the outsider. He organized the biggest protest in Malaysia’s history on Sept. 20, attended by up to 50,000 people, to call for reform. That day, Britain’s Queen Elizabeth II was in town for the Commonwealth Games. Mahathir ordered Anwar’s arrest that night. A week later, Anwar appeared in court, bruised from what he said was a police beating. **[H: Now we have gotten to the gutter of garbage again. Remember that the Commonwealth Games were on and thousands upon thousands of people were present—not for a protest but as visitors. The protest took place near a church yet, where Queen Elizabeth would be seen by the cameras and the people had come to see the Queen. Is this dirty pool or what? Now as to that bruised eye: we have heard it all. That eye was NOTHING and yet we have been told by Anwar that the police “beat him unconscious” and then later the former head of Hong Kong, idiot that he IS, said his good friend was “beaten to a pulp”. If these things are true then either the police in Kuala Lumpur are not as good as the cops who beat people unconscious in the U.S., are wimps, or the unconsciousness comes from a blow to the upper cheek area below the eye? This is a laughing stock item here in Kuala Lumpur because Anwar showed up in court immediately with a small bruise but no infirmities. Does this not sound like a Zionist screenplay of slapstick idiocy?]**

Whatever the verdict in Anwar’s trial, it is unlikely to end the momentum for reform kindled by his ouster. Clearly Malaysia’s reform movement has legs, although no one wants a repeat of the violence that devastated Indonesia during Suharto’s fall. It looks like the transition won’t be easy. Mahathir seems intent on staying in power to safeguard the economic structure he spent 17 years building. But even if Anwar vanishes from power, the questions he posed in the turbulent year will haunt his stern mentor for years to come.

## SECRET REPORT EXPOSES ZIONIST SCAM

Clinton's willingness to throw

Apart from the deception operation launched by the White House to set up Congress for passage of the corrupt North American Free Trade Agreement (NAFTA), the Clinton administration has managed to get away with some sweeping falsehoods, scams and outright lies involving issues far more serious than the president's revolting sexual practices, a *Spotlight* survey has found.

To ingratiate himself with the powerful Zionist lobby, the White House threw its weight behind the clamor or so-called “Holocaust survivors” to receive cash compensation for any calamities they suffered—as did tens of millions of other wartime “survivors”—during World War II.

Stuart Eizenstat, a prominent Zionist advocate promoted to deputy secretary of state, issued an official report suggesting that Swiss banks, among others, owed the “Holocausters” billions of dollars in long-dormant secret bank accounts and other obligations.

Now a prestigious special commission under former U.S. Federal Reserve Chairman Paul Volcker, impeded by the Swiss to investigate all reports of wartime losses, dormant deposits or disputed transactions, is about to issue its final report after two years of painstaking inquiry.

The commission has found that, even with undocumented or dubious claims given the benefit of the doubt, the total liabilities of Swiss financial institutions dating back to

World War II do not exceed \$70 million, the *Spotlight* has learned from well-informed diplomatic sources.

“Note that Volcker ran a broad investigation including Israeli ‘Holocaust historians’, experienced accountants, document examiners and other researchers, all of whom bent over to not exclude any claims stemming from World War II,” says Franz Mehli, a Swiss investigative journalist.

But intimidated by harsh vituperation from the Israel lobby, and by fear of U.S. sanctions threatened by the Clinton administration, two leading Swiss banks have already agreed to hand over \$1.25 billion in compensation to self-styled “Holocaust survivors”. This was more than 15 times the total Swiss liability assessed by the Volcker Commission.

On behalf of the Clinton White House, Eizenstat expressed “gratification” at this “settlement”. But, much as this populist newspaper has warned, the Swiss bank's surrender to such extortionate demands settled nothing. To the contrary, it has set off a feeding frenzy among professional “Holocausters” and their insatiable lawyers.

“Any American who buys a Ford or a Chrysler car next year, not to mention a Volkswagon or a Mercedes, will likely pay extra,” predicted Mehli. “Believe it or not, these companies—along with dozens of banks and insurance firms—are being sued now by ‘Holocaust litigators’ for allegedly coercive labor and business practices during World War II.”

The craven submission of the two Swiss banks willing to put up more than \$1 billion in what is essentially a blackmail payoff is producing “disastrous results,” warned Dr. Aldo Milinkovich, a former U.S. Treasury chief examiner now serving as a Wall Street consultant.

“The deal has exposed any U.S. manufacturing company with wartime European subsidiaries—not to mention Chrysler, recently merged with Daimler-Benz—to demands for so-called ‘survivor compensation,’” explained this respected observer.

Other economists expressed similar views. “Clinton's willingness to join the Zionist lobby in such an immense, shameless ripoff also reveals that he lies whenever he argues the necessity and inviolability of ‘free trade,’” says financial writer Tarquin de Avila, who covers Wall Street for a number of Latin

American news organizations.

“Now that the lies Clinton used to promote his \$50 billion post-NAFTA bailout of Mexico's payments system are being exposed, it's scandal time south of the border,” related this veteran reporter.

Not only was the \$50 billion misappropriated by corrupt bureaucrats and dishonest bankers, “it turns out that the open-handed U.S. bailout emboldened Mexican financiers to steal even more while the stealing was good,” recounted Avila.

Now the Mexican Congress is wrestling with the problem of what to do about some \$65 billion in missing assets—largely money that vanished into the black hole of the nation's crooked banks.

“Clinton, as always, has a ready answer,” noted Milinkovich. “He is proposing yet another, bigger, global bailout to prop up wobbly banks from Brazil to Japan. But before they submit to another such bloodletting, U.S. taxpayers should remember that these White House policies are based on lies—lies far more costly than any of Clinton's perjured protests about his sexual deviations.”

responsible for the recent blackmail payments of \$1.25 billion to alleged Holocaust survivors.

"This was totally deficient conduct of affairs by the Swiss government," said Richard G. Anderegg, a correspondent for *Solothurner Zeitung*. "I refuse to blame the Zionist organizations."

Jewish organizations fear losing a sense of Jewishness once Jews are accepted into society. Promoters use the Holocaust as a tie that binds to overcome what many observers call an identity crisis.

"They have their problems and they lash out," Anderegg added. "OK, that happens in politics. You have a guy who hits you, if you don't hit back, that's your problem."

Bern failed to "hit back" once Holocaust promoters, headed by the World Jewish Congress (WJC), targeted Swiss banks as Nazi collaborators.

Anderegg served in the Swiss army in 1940. He said Bern should have set the historical scene as it was, rather than as Holocaust promoters want it cast.

### NOT ABOUT JEWS

"The Second World War was not about Jews, although they try to make it look that way," Anderegg said.

Had historians, or the Swiss, reminded the world of this, Anderegg suggests things would have ended differently.

"The big failure of our government was they never tried to say, 'Think in terms of when this happened. The Swiss had good reason to do what they did'," the journalist said. "Discussing with these Zionist organizations became like discussing with communists before the end of the Cold War.

"They had their dialectic materialism and part of their debating skill consisted of bringing you right in the beginning to a point where you shied away from using your logic," Anderegg added. "You had to accept theirs. Then you were cooked."

### PR OFFENSIVE

When Kurt Waldheim was running for the Austrian presidency in 1986, the WJC opened a worldwide public relations offensive against him. Powerfully placed Jews brought the moral authority of the United States to bear against "the alleged Nazi war criminal" Waldheim.

Once the Austrians elected Waldheim, Jewish activists widened their campaign against all of Austria. For the six years Waldheim sat as president, he was *persona non grata* and Austria was treated in some circles as a leper nation.

But a careful examination of the facts reveal Waldheim was neither a Nazi nor a war criminal. But Jews in key positions, such as Eli Rosenbaum—director of the U.S. government's Nazi-hunting wing and a former WJC flunky—have swept the facts under the rug.

Something very similar happened during the Swiss/Nazi gold saga, according to the Swiss journalist.

"After the Waldheim campaign, a couple of leading lights [at the WJC] said it's cost us a pretty penny," Anderegg said. "We've been successful, but who cares?"

"Next time, we need to show a balance in hard economic terms," he added. "They kept looking. People like [WJC's Elan] Steinberg and [WJC's Israel] Singer said they then recalled that there was a tremendous loss of assets after the Second World War. They began to look at the best way to get it."

"The first thing they got was that the Swiss National Bank had been a free market accessible to the Germans," Anderegg said. "The trick was to mount some sort of a propaganda with 'Nazi, Nazi, Nazi'. That made every contact with Germany look like something forbidden.

"That's when our government should have stepped in," he added.

Instead, Bern stepped as far away as it could, according to the journalist.

"The government should have said, 'Germany is and was our biggest foreign market. There was no reason for us as a non-belligerent to have unemployment in our country and stop working for that market'," Anderegg explained. "After all, we tried to work with the French and British, but they were so ill prepared for the war that they got booted out of Europe."

With the Swiss government turning a blind eye to the situation, Edgar Bronfman's WJC


again brought the authority of the U.S. government behind the claims of Holocaust promoters.

Sen. Alfonse D'Amato (R-N.Y.) held hearings in Washington. The Senate Banking Committee uncovered old documents and accepted the written words as fact.

"After 50 years, a lot of documents have been freed that contain a lot of [misleading] raw intelligence," Anderegg said. "Nothing else. Nothing proven. Not one of these documents, which D'Amato especially has launched on the world scene, has added to it the evaluation.

"This has led to a one-sided evaluation through people who wanted something from Switzerland," he added.

Under Secretary of Commerce Stuart Eizenstat served as Bill Clinton's special envoy on a U.S. delegation seeking restitution. Eizenstat served as little more than a lobbyist for the Holocaust promoters, but his presence gave the promoters U.S. muscle.

"This is an exercise in crisis on both sides," Anderegg said. "Our weak government, an identity crisis of the Jewish Diaspora, plus a pretty dishonest role played by the American government. Eizenstat's position is extremely questionable."

## Nora's Research Corner

### An Update On National Fronts

10/15/98 NORA BOYLES

I am going to quote below from an article in *The Final Call* newspaper, 10/6/98 issue, regarding the rise in what the author of the article calls extreme right-wing political parties in Australia, Austria, Belgium, France, Germany, Italy and Norway in a report to the U.N. General Assembly. My comments will follow the article [quote]:

#### UNITED NATIONS WORRIED ABOUT THE SPREAD OF GLOBAL RACISM

UNITED NATIONS (*IPS*)—The United Nations is seriously concerned over evidence of an increase in racism, racial discrimination and xenophobia throughout the world.

“Neo-fascism and neo-nazism are gaining ground in many countries—especially in Europe,” warns Maurice Glele-Ahanhanzo, UN Special Rapporteur of the Commission on Human Rights.

The dramatic increase in racism is reflected by the recent electoral victories of extreme right-wing parties in Australia, Austria, Belgium, France, Germany, Italy and Norway. These groups advocate xenophobia, attacks on ethnic, national and religious minorities, and racial and ethnic parties in countries where they are active, Mr. Glele-Ahanhanzo says.

The National Party in Australia, which is against immigrants in that country, won 23 percent of the votes in parliamentary elections in the state of Queensland early this year.

The Liberal Party in Austria has won 22.6 percent of the votes and has 41 members in Parliament. In France, the National Front has won about 15 percent of the votes in various elections, and its influence is growing, he says.

In Italy, the National Alliance has secured about 15.7 percent of the votes and has 53 members in Parliament while the Progress Party in Norway has become the second largest party in that country, with 22 percent of the votes and 41 members of Parliament.

In Germany, the Deutsche Volkunion won 13.2 percent of the votes and 16 seats in

recent regional elections. The Flemish Vlaams Blok in Belgium won 12.3 percent of the votes and has 11 representatives in the Federal Parliament, 15 in the Flemish Parliament, five in the Senate and two in the Brussels regional parliament.

In France, about 70,000 of the 150,000 applications submitted for the regularization of the status of aliens were rejected. In an opinion poll by the French National Commission on Human Rights in early 1998, 38 percent of all French men and women said they were openly racist, 27 percent said there are too many Blacks in France while 56 percent said there are too many Arabs.

In a new 10-page report to the General assembly, Mr. Glele-Ahanhanzo says that “this growing increase in the power of the extreme right-wing parties is a cause of concern.”

“International public opinion and non-governmental and international organizations, which seems to pay attention only to open conflicts or violent manifestations of fascism or xenophobia, should be alerted,” the study noted.

These parties, he said, are “exploiting an economic and social climate characterized by fear and despair endangered by the combined effects of globalization, identity crises and social exclusion.”

“They have also made changes designed to make them look like radical right-wing democratic parties, softening their image while

enabling them to conceal an unchanged preference for racism and xenophobia,” he added.

The study quotes an April 1998 article in *Le Monde Diplomatique* which says that “for purely electoral motives, classic right-wing parties, are increasingly embracing the slogans of extreme right-wing parties.”

“Some young people are also receptive to xenophobic slogans,” it commented.

The study singles out the Internet, the information superhighway, as one of the major purveyors of racism. “Over 200 sites worldwide are disseminating racist propaganda,” it adds.

The study also says there is increased discriminating against immigrant and migrant workers both in developed and developing nations. “The problem of migrant workers also exists in Africa, and some countries have organized charters for the large-scale deportation of undocumented aliens or have detained such aliens in holding camps prior to their repatriation.”

[End quote]

First, it should be noted that most of the nations cited are in the European Economic Union, but all are of course, within the United Nations plans for the New World Order, and feeling the costs, restrictions and suppressions of that plan. The grand scheme of the New World Order is to do away with *all* nationalism, or national sovereignty. (It is also the grand scheme of Communism and Humanism.) In fact, the author of the article, Maurice Glele-Ahanhanzo, UN Rapporteur of the Commission on Human Rights, states: “These parties...are exploiting an economic and social climate characterized by fear and despair endangered by the combined effects of globalization, identity crises and social exclusion.” In other words, he admits that the New World Order (or globalization) is the cause of the bad “climate”.

The United Nations is, it should be remembered, a focal point of that globalization.

Second, Mr. Glele-Ahanhanzo links the electoral victories of what he calls “extreme right wing parties” to “neo-fascism and neo-nazism”! Could that mean, if you don’t agree with the planned one-world dictatorship of the New World Order, you are a Fascist or a Nazi? You see how the meanings get tangled-up? The Nazis and so-called Fascists of World War II were under the dictators, Hitler and Mussolini. Today, the words, Fascist and Nazis are indiscriminately being thrown at anyone or group that does not agree with globalization, whether they are National, Liberal, Progressive or whatever.

Third, I would say that most of the problems with immigration have their roots in the economic situation. When competition for jobs becomes an issue, it is a matter of who has first

chance at the available jobs. This world-wide problem has been engineered by the global trade alliances and the international bankers, it is not "xenophobia" (or a fear or hatred of foreigners) in its true sense but a need to return to an ordered and participatory way of life, something the U.N. and the New World Order do not intend and are not able to bring about. In fact I would say that the increasing rise of what could be called opposition parties is proof that the New World Order is not working, including the European Economic Union and the United Nations.

You may recall that the reason the Nazis wanted to export the Jews from Germany was because the Jews had taken over the financial control of the country, and the German people were in a situation they believed they must change in order to continue as a national sovereign country.

Fourth, the people of the world were not given a vote in the growth of the New World Order. They were fed a great deal of propaganda promoting it in one way or another, but in fact had nothing to say about it. It is not surprising that now those who are waking up to that fact want to return to some measure of control over their lives. The U.N. Charters and Treaties do not conform to most national constitutions. They have been mostly put in place by leaders who assumed greater power than that given by the people or simply went over-the-heads of the citizenry without due process or regard for their wishes. It is almost certain that this kind of dictatorship will sooner or later meet with a lack of support, if not open opposition, of a people considering themselves to be free.

Fifth: I have not studied the purposes of all of the named national political groups or the problems they face. However, I do agree that there are those who do want to change immigration laws or practices. A country should be able to determine how many additional persons it can absorb on a long-term basis, and this always has to do with space and economic opportunity, as well as the beliefs of the citizens. We are not talking here about emergencies, but long-term plans for an ordered economy, culture and growth. To call this "xenophobia" is not appropriate, although I can understand where a long period of unbalanced immigration, deteriorating and unfair economic conditions, and political crises could cause it in some people.

One could ask here: What have the international bankers, the monopolizing merchants, the "elite" power brokers and their New World Order done to improve the situation? Will they come down with a heavy hand and foot on the opposition? It will be interesting to see what unfolds! As Mr. Glele-Ahanhanzo of the U.N. states: "this growing increase in the power of extreme right-wing parties is a concern... International public opinion and non-governmental and international organizations, which seem to pay attention only to open conflicts or violent manifestations of fascism or xenophobia, should be alerted..."

So—they will start the "international public opinion" by calling them Fascists, Nazis and xenophobes, and alert the non-governmental (think-tanks and foundations that pay no taxes and purposely infiltrated and controlled environmental groups of high profile, as well as

religious groups, political parties, etc.) and international organizations (regional agencies such as NATO, cooperating investigative units, and other regional alliances such as trade, military, etc.) to stamp out and discredit the opposition.

In the plans for the World Government Federation, which I have written about in previous articles, the non-governmental organizations and international organizations have a vote in the World Government Federation but the people have no say. Obviously, the U.N. General Assembly is aware of the World Government Federation plans and are integrating it and being alerted to carry-out its mandates. (The U.N. was sold to the people upon the premises that it would provide a forum for all world governments to talk out their problems. However, the plans of the "Elite" and world political, banking, trade and military controllers were to use it as the first step in establishing their plan for an eventual fully authorized and managed World Government Federation. You see a hint of their plans here in action.)

Sixth: There is a perfect example of how the international trading monopolies work and crowd out the private or national business sectors close to my home, and I expect close to many people these days.

During a news report on Channel 29 out of Bakersfield, California on 10/7/98, I learned about ground-breaking for a huge International Mall in Bakersfield. It is located in an area which can support much growth, and is near to the railroad—an important asset necessary for transporting International goods from the Port of Los Angeles to Bakersfield. (You may also be aware of the ever-increasing trade deficit caused by the boat loads of cheap Asian goods entering our ports on the West Coast, and empty ships returning to Asia. In other words, the Asians cannot afford to buy American goods for the return trip.)

The news reporters were enthusiastic over the potential for new jobs with the creation of this huge mall. How many people heard the statements that this international operation would be using rules other than that required of the rest of the business sector? Yes, it was reported that they will be setting their own "International Rules" on taxes! The one example given on TV was the tax on fabric. Businesses generally pay a tax on a bolt of cloth. However, the internationalists only pay taxes on the cloth used! That means that when a garment is cut from the bolt of cloth, the scraps not used are not counted! We were told these scraps amount to 50% of the fabric! I suppose one could extrapolate this method of taxation to other goods such as building material, etc. What other goodies these "Internationalist Rules" provide to the owners of the proposed mall was not stated. Nevertheless this one example provides the "writing on the wall". The private or national business sector of any country or state is intended to carry the major tax burdens of government, roads, services, etc., for these "internationalists", making them far less able to compete in what the internationalists call "free trade". The jobs provided by this international group are literally jobs to be taken from our own business sector, which is being foreclosed!

Worse, the clothing goods being shipped in through the Port of Los Angeles from Asia are largely produced through slave labor. The wages


provided to the Asians by the "internationalists" will make it impossible for them to afford to buy American goods. Those empty return ships will remain empty until soon Americans will be unable to buy the Asian goods! This should not happen in a sovereign national country. It certainly has to do with a form of racism, that of the "internationalists" and their cohorts who place themselves above the rest of us. This kind of racism can surely cause other racial unrest due to governmental inequities, the close-down of private and national business, high taxes and ever increasing "international" intrusion into our lives.

There was no statement made on the TV news report as to how these "internationalists" worked out such a sweet deal for themselves with the various levels of government! It would appear on the surface that they are arrogantly declaring their location to be "international soil", and not a part of the County of Kern, State of California and Country of the U.S. of A., to which we in this location pay taxes! Are these "internationalists" just testing the public's awareness and potential response, or has the One World Government already become so powerful that they feel secure in flaunting their "International Rules" onto a sleepy people who believe they are still somehow citizens of a particular sovereign country?

Who are these "internationalists"? Could they be the ones about which nationalists are xenophobic? Who made the "Internationalist Rules" laws? Did you have any say in it or vote on it?

This is the way your sovereignty is taken away, with long-term planning and bit by bit.

The same type of scheme is being promulgated on the land either side of the U.S.A./Mexico Border. Large corporations, among them Dodge and A.T.&T., are producing their products with Mexican labor at \$2.00 per hour. They have arranged a deal whereby they pay no taxes. They promised to build public infrastructures to handle their business (i.e., sanitation facilities, roads, etc.) but have not done so. The small towns cannot afford to build what is necessary to accommodate the influx of people for the jobs. The new wage earners do not receive enough to pay taxes, or to build living quarters. The area has become a shanty town for workers and an environmental hazard of the first order. Apparently the "internationalists" are exempt from environmental rules as well as taxes! Still, the Dodge cars and trucks sell for market prices in the U.S. of A., and A.T.&T. prices are as high as the rest of the communication services. It is also true that the more cheaply-made clothing being shipped in from Asia sells for ever-increasing prices in America.

It is a forgone conclusion that the lower paid wage-earners will sooner or later resent those low wages, and the U.S. workers thrown out of jobs will resent those who took them away, and the government workers will resent the industries who do not shoulder their responsibilities and cause government layoffs and shutdowns. I only hope all of them see where lies the true cause of their problems, and those who are actually robbing them all for huge profits through grossly unfair international trade practices, along with those who made it possible through corrupt and unconstitutional government practices and sweet deals in this country and abroad.

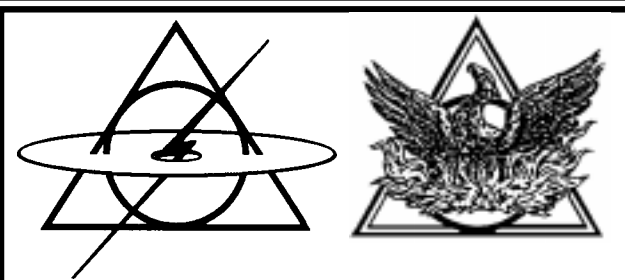
